

## REWARD TERMS AND CONDITIONS

### “TOP CHARITY 2023” (“TERMS AND CONDITIONS”)

#### § 1

1. The "Top Charity 2023" Award, hereinafter referred to as the "**Award**", is granted on the initiative of the Omenaa Foundation with its registered office in Warsaw, ul. Heleny Kozłowskiej 1 lok. 43, 00-710 Warsaw, entered into the register of associations, other social and professional organizations, foundations and independent public health care facilities of the National Court Register kept by the District Court for the capital city of Warsaw in Warsaw, 13th Commercial Division of the National Court Register, under KRS number 0000509539, nip: 5272719133, REGON: 147357946 ("**Organizer**").
2. The aim of the Award is to honor entrepreneurs for their personal commitment, passion and dedication to helping those in need.
3. The prize is awarded to natural persons who have been running their own company for at least 5 (five) years (as individual entrepreneurs or partners or shareholders of a commercial company) and who by themselves provide charity/philanthropy - thus, demonstrating personal contribution to help others.

#### § 2

4. The prize is awarded to 3 (three) winners:
  - a. 2 (two) winners ("**Jury Prize Winners**") - who are selected by the Jury specially appointed for this purpose by the Organiser of the Prize ("**Jury**");
  - b. 1 (one) winner ("**Internet users' prize winner**") – who is selected by way of the vote of registered Internet users, subject to the provisions of § 4 section 6 of the Regulations.
5. Candidature for the Prize is free of charge.

#### § 3

1. The winners of the Jury Prize are selected from among the candidates nominated by the members of the Jury.
2. The jury shall be composed of 11 (eleven) members. The system consists of:

3. Each of the members of the Jury is entitled to submit a maximum of 3 (three) candidates for the Prize. Applications for the Jury Prize Winners may be submitted by the members of the Jury until 23:59 on 31 January 2023, to the Organiser's e-mail address: [katarzyna@omenaafoundation.com](mailto:katarzyna@omenaafoundation.com).
  4. The Organiser shall verify the candidates submitted by the members of the Jury, in particular, regarding the candidates' compliance with the requirements set out in § 1 section 3 of the Regulations and in order to obtain from candidates, their consent to apply for the Prize, including the processing of their personal data by the Organizer.
  5. Among the candidates for the Prize submitted by the members of the Jury who successfully passed the verification carried out by the Organizer and the Jury until 23:59 on March 31, 2023, 2 (two) Jury Prize Winners are to be selected by way of voting. The vote shall take place at a meeting of the Jury held remotely and convened by the President of the Jury. The vote shall be preceded by a discussion.
  6. Voting is open.
  7. Each member of the Jury may cast a maximum of 2 (two) votes.
  8. The winners of the Jury Prize are the 2 (two) candidates who will have obtained the largest number of votes within the Jury. In the event of a tie vote, the Chairperson of the Jury shall decide on the selection of the Jury Prize Winner.

#### **§ 4**

1. The selection of the Internet Users Award Winner occurs via registered Internet users, by submitting candidates via the form available on the Organizer's website: <https://omenaafoundation.com/wielka-aukcja-charytatywna-2023/>.
2. Any application shall be tantamount to the applicant casting a vote for the candidate concerned.
3. Submissions can be made from September 24, 2022 to 23:59 on 31 January 2023.
4. The Organiser will carry out a verification of candidates submitted by the registered Internet users, in particular in the scope of meeting the requirements set out in § 1 section 3 of the Regulations and in order to obtain from candidates, their consent to apply for the Prize, and to the processing of their personal data by the Organizer.
5. After the period referred to in section 3 above and after verifying the candidates, the Organizer will make a final count of the submitted applications /votes cast.
6. The winner of the Internet users' award will be the candidate among the candidates successfully verified by the Organizer, who obtained the largest number of applications (votes). In the event of a tie vote, the Jury shall make the final selection for the Winner of the Internet Users' Prize through a vote carried out in accordance with the principles set out in § 3 of the Regulations.

## § 5

1. Announcement of the winners of the Prize (i.e. The winners of the Jury Prize and the Internet users Prize winner) and the award of the "Top Charity 2023" statuettes will take place on 3 June 2023, at the Palace of King Jan III, in Wilanów, in the event organized by the Organiser entitled the "Great Charity Auction – Top Charity 2023".
2. The Organiser shall inform the Prize winners of its award at least 2 (two) weeks before the planned date of announcement of the Prize winners. Winners are obliged not to publish this news until the winners are officially announced by the Organizer.

## § 6

1. The Administrator of personal data collected during the Competition is the Organizer. The processing of personal data will take place on the principles provided for in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).
